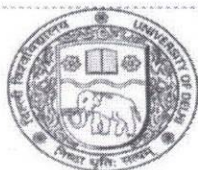


**Every Synopsis of Research Proposal (Not exceeding 10 pages) should contain the following:**

- (i) Title of the Research Proposal
- (ii) Statement of the Problem
- (iii) Literature Survey
- (iv) Research Gaps
- (v) Objectives of the Study
- (vi) Research Questions
- (vii) Hypothesis
- (viii) Research Methodology
- (ix) Scope & Limitation of Study
- (x) Tentative Chapterisation

### **Note:**

1. The screening of the candidates for the interview will be as per the as per the University Grants Commission (Minimum Standard and Procedures for Award of Ph.D. Degree) dated 7 November, 2022 *and* University of Delhi Ordinance VI of the University (Amendment to the Procedure for Award of Master of Philosophy (MPhil) and Doctor of Philosophy (PhD) Degree, dated September 2023).
2. Candidates who have qualification on the basis of UGC-NET examination December 2023 and June 2024 (Qualified NET and/or PhD Admission).
3. Candidates who have qualified for fellowship and scholarship through national

- level tests (JRF, NFOBC, NFSC, NFST, NFPwD, etc.).
4. Teachers and Non-Teaching Staff who are in the permanent service of the University of Delhi.
  5. Only those candidates will be considered for the screening who has applied through the university admission portal and upload the relevant documents.
  6. Candidates who have applied through the University portal but fails to apply online as per this notice will not be considered for screening/ for interviews.
  7. Refer to the **Bulletin of Information** (See Annexure-II for Ordinance VI of the University) for more details regarding seat matrix.
